## NOTICE

Taking cognizance of the order passed by the Hon'ble High Court, Calcutta in the WPA 5890 of 2020 dtd. 13.10.2020 and the SLP dairy No. 22811/2020 granted by the Hon'ble Supreme Court dtd. 28.10.2020, in the matter of, inter alia, the fees to be charged by private unaided School, during the Covid pandemic during session 2020-21, the school administration has taken the following measures in the compliance of the above said order/s.

1. The hike in fees for the session 2020-21 has been rolled back and revised fee structure for the session 2020-21 without any fee hike has been already circulated to all the enrolled students/guardians. Also all the fee bills have been revised.
2. No transport fee has been charged till date in the session 2020-21 and it will be charged when it will be resumed.
3. No late fine/fee will be charged till 15.12.2020 in the session 2020-21 irrespective of the fee rules of school.
4. No student has been disallowed from the online classes and online examination irrespective of the payment of fees due till date.
5. In immediate compliance within stipulated short time frame of the above mentioned order/s of the Hon'ble High Court and Hon'ble Supreme Court, it is hereby informed to all the Parents that 20 percent reduction in School Tuition and Annual fees from the month beginning April'2020 till the month following the one in which the school reopen in the physical mode will be accepted by the school only for the session 2020-21 without prejudice to its rights and contentions and further steps in this regards will be taken in light of order /s passed by the Hon'ble Supreme Court.
6. Parents are requested not to avail any reduction in school fees as mentioned above, if their financial condition is good enough to pay school fee.
7. All parents are requested to note that as per the direction of the Hon'ble High Court the school fees payable for the period upto 30.11.2020 is required to be tendered till 30.11.2020.

We thank all parents who have paid the fees timely and any excess payment if paid will be adjusted wef. December'2020.

Considering the students engagement and academic quadrant of the Students, our Teachers are putting in their best effort through the online classes and are committed to their responsibility of providing the latest curriculum through online methods and pedagogies so that the students do not get the anxiety of losing out in these COVID times.
